# 3 Tips to Get a Journal's "Call for Papers" Submission Accepted

## Title & Abstract — Get to the point!

The title and the abstract have to speak to the content the authors are speaking about and be inline with the CFP's topic or theme.

# Submit early, submit often

If you are well prepared with your material ahead of time, as you should be, prospective authors who submit earlier stand a higher chance of getting selected because there is less competition.

## Follow-up and be responsive

CFP's guest editors like to tap speakers who they are familiar with and have had a good prior experience. If you are rather "new and unknown," this doesn't mean CFP's guest editors won't take a chance on you, but it's in your best interest to personally follow-up with email to build a relationship. The CFP's guest editors might then give your paper a closer look. Above all though, be responsive to communication.


